Mr. Conley indicated that at this time that he doesn't believe Wellman Paving looks to move forward with the agreement for the

It is assumed that the agreement would include dates to comply before the town would issue a deed. The Town Council asked the manager to report back at the next meeting. In the meantime, Mr. Geisel offered to start the clean up of the property to demonstrate to the town that he is serious about paying the taxes and cleaning up the property. B. New Business

- Winter Sand- Manager Crooker indicated that last year the Town Council agreed to
 extend the contract for another year with Wellman Paving at the same price as the
 previous year. Manager Crooker indicated that absent the same type of offer from the
 contractor again this year that he would like to go ahead and prepare a bid for the
 provision of sand by a contractor to the town. The Town Council authorized the manager
 to proceed with the bid.
- 2. Notice of Uncollectable Taxes- Manager Crooker indicated that the Town Council had discussed account number 2077 during numerous prior meetings of the town council. He noted that the town council authorized the town manager to negotiate a final settlement of money for the mobile home in order to prevent the town for having to pay for disposing of the mobile home since it was on someone else's property. The manager reported that they paid \$500 as he had previously reported and now the Town Manager was asking to the Town Council to approve writing the remaining balance of taxes, interests, and costs off as uncollectable. Councilor English-Flannagan motioned to approve and sign the notice of uncollectable taxes as presented. Councilor Ronco seconded the motion. Motion passed unanimously.
